5. Discussion and/or Action Items

A. Consider Adoption of Resolution 2016-04 Initiating a Basin Boundary Modification Request GM reported The Sustainable Groundwater Management Act (SGMA) requires that Groundwater Sustainability Agencies (GSAs) be formed to manage groundwater basins as defined by Department of Water Resources (DWR) Bulletin 118-Update 2003 (B118) by 2040 for the case of high priority and critically overdrafted basins such as the Pajaro Valley Basin. March 31, 2016 is the deadline for DWR to accept Basin Boundary Modification requests. SGMA requires entire basins to be managed. Potentially Un-Managed Areas (PUMAs) that exist after the June 30, 2017 GSA formation deadline, may lead to a basin being designated as probationary by the State Water Resources Control Board (Water Board). It is in the best interest of PVWMA to take reasonable steps that lead to the management of the entire Pajaro Valley Basin to not loose local control or other actions as determined by the Water Board. The modifications being considered at this time are jurisdictional in nature.

page 5 of 187. When DWR deems the request complete, PVWMA will have 5 working days to renotify systems in the affected basins of the 30 day public input period.

Margie Kay, requested PVWMA to move forward with request of "green area" to become a part of 180-400, Salinas Valley.

Vickie Morris, GM Aromas Water District thanked PVWMA for leaving the "orange area" under Aromas Water District and until their Board makes a final decision on what to do with that area. Aromas Water District prefers to maintain their autonomy.

B. Consider adoption of Resolution 2016-05 Authorizing General Manager to Execute Installment Sale Agreement with the State Water Resources Control Board

GM was reported that The State Revolving Fund (SRF) loan package, which Staff has been working on this past year, has been finalized and is ready for execution. Installment Sale Agreements may not exceed \$9,968,000 and the annual interest rate represented by the Installment Sale agreements may not exceed 1%.
