10. **Discussion and/or Action Items**

- A. Consider Adoption of Resolution 2019-01 Amending the Public Records Act Disclosure Policy and Guidelines

GM Lockwood provided background information. The Board of Directors adopted Resolution 2002-12, Public Records Act Disclosure Policy and Guidelines, on April 17, 2002. Seventeen years have passed since the original adoption. Staff worked with counsel to review the original policy and develop proposed updates in accordance with changes to the law. Staff presented the Policy to the Administration & Finance Committee on January 15, 2019, and after discussion, the Committee made a recommendation to bring the Policy to the Board. The Board discussed the policy.

**Action:** Director Bannister moved, as amended, for Board to Adopt Resolution 2019-01, Amending the Public Records Act Disclosure Policy and Guidelines, change to Section 4.2 to read: “The mailing address, telephone number, and email address where the person making the request may be contacted”; Seconded by Director Broz.

- B. Consider Adoption of Resolution 2019-02 Amending the Records Retention and Destruction Policy**  
 GM Lockwood provided background information. The Board of Directors adopted Resolution 2005-22, Records Retention and Destruction Policy, on September 21, 2005. Resolution 2005-22 formalized PV Water’s policy regarding retention and destruction of public records. Staff and counsel worked collaboratively to review and develop recommended updates to the Records Retention and Destruction Policy. Staff presented the Policy to the Administration & Finance Committee on January 15, 2019, and after discussion, the Committee made a recommendation to bring the Policy to the Board. The Board discussed the Policy.

**Action:** Director Culbertson moved, as amended, for Board to Adopt Resolution 2019-02, Amending the Records Retention and Destruction Policy, changing the Records Retention Schedule: Public Outreach, Public Materials, Retention Period with attachments, from Two Years to Permanent; Seconded by Director Broz.

 GM Lockwood provided background information. The Board of Directors adopted Resolution 2005-23, Establishing an Email Policy, on September 21, 2005. This Policy complemented Resolution 2002-12, adopting a Public Records Act Disclosure Policy and Guidelines and Resolution 2005-22 establishing a Records Retention Policy. Staff and counsel worked collaboratively to review the Email Policy and develop a more inclusive Electronic Communications Policy. Staff presented the Policy to the Administration & Finance Committee on January 15, 2019, and after discussion, the Committee made a recommendation to bring the Policy to the Board. The Board discussed the Policy.
